This agreement's purpose is for the sale of the AKC purebred Cavalier King Charles, American Cocker Spaniel or French Bulldog puppy, described above. Immunizations, (first puppy vaccination) physical, and de-worming completed by a licensed veterinarian and records are provided to the buyer with the puppy. To the best of our knowledge, the puppy stated above is in good health. Five Star Farms, LLC guarantees a healthy companion pet, but does NOT guarantee breeding ability or show quality, adult size, coat type, cosmetic flaws or temperament. If the puppy has been accepted and taken home, deciding to change and get another puppy is not an option. To return a healthy puppy at this time is to forfeit the entire cost.

Health Guarantee:

Puppy is guaranteed until one year of age against genetic/congenital defects, which would cause death or the need for the puppy to be humanely euthanized. Anything that is considered non-lethal has no guarantee for any period of time. Should the puppy be diagnosed with any life threatening congenital defect, a veterinarian's report must be submitted in writing and signed by a licensed veterinarian at Buyer's expense. Seller MUST be notified of the problem within 24 hours of the licensed veterinarian's determination and must receive the veterinarian report. Seller reserves the right to have the puppy examined by a Vet of the seller's choice before any exchange or refund. If the puppy is euthanized, an autopsy to determine cause of death MUST be performed by a licensed veterinarian, at the Buyer's expense, and that cause must be proven congenital, for an exchange or refund (of puppy's purchase price only) to be applicable. Original AKC papers and Puppy MUST be returned to Seller for a refund. NO EXCEPTIONS.

Any and all shipping costs to return the puppy to the Seller are the responsibility of the Buyer. Any and all veterinary charges incurred by the purchaser after possession of puppy, are the sole responsibility of the purchaser and will under no circumstances be paid by the seller.



### Payment for Puppy

A non-refundable, but transferable deposit of \$400 for Cavalier King Charles Spaniel \$300 for Cocker Spaniel, or \$500 for French Bulldog is required to hold a puppy for you (payable by the link **PUPPY PAYMENT** on our website Home Page. We will accept PayPal, Venmo, Zelle and a Major Credit Card via a phone call. With this deposit, we will hold your puppy until is it time for the puppy to leave our home (usually when the puppy is around 8 weeks of age). If you have not made arrangements for pick-up of your puppy within 5 days after the puppy reaches 8 weeks, we reserve the right to sell your puppy to another buyer, and you will lose your deposit and all rights to that puppy. If you DO want your puppy but are unable to pick him or her up within 3 days of the 8 week date, please arrange this with us and we will charge an additional \$40 a day boarding fee until you are able to pick up your puppy.

A licensed veterinarian will examine each puppy before they are 8 weeks of age. Full exam record including general examination will be disclosed to buyers in this report. Although it is rare that a problem should exist, if one does, and the vet report is not to your satisfaction, you may choose another puppy from a future litter. You will still retain your spot on the waitlist.

When your puppy is ready for his/her new home, the full price (minus the deposit) will need to be paid before you can take your puppy home with you. This payment should be in cash or through PayPal, Venmo or Square (using a debit or credit card) at time of pick up. Any bank check, or personal checks will not be accepted for the balance amount.

If in the event for any reason you are unable to keep your Five Star Farms puppy or dog, we will accept them back without questions and without a refund.

By placing a Deposit with Five Star Farms LLC you have agreed to the terms of this contact with or without a signature. Deposits are Non Refundable but are Transferable to another puppy. Deposits do not expire.

This is a legally binding agreement and any and all litigations will be handled in Greenville County South Carolina\*\*

All guarantees by Five Star Farms shall become null and void if the puppy is sold, given away, or in any way transferred to another person other than the Buyer.
